Cat Town will pay for the following through an Oakland, California, veterinary hospital of its choice (“Cat Town’s Vet”), or vet outside of Oakland if preapproved by Cat Town:

- Exam fees annually, or in case of health concerns when a Cat Town representative agrees a vet exam is warranted.
- Medical/surgical procedures and tests, prescription medications/foods, and supplements recommended—or approved— by Cat Town’s Vet.

Cat Town will not cover:

- Expensive diagnostics.
- Extreme life-saving measures that prolong the cat’s suffering, significantly impair the cat’s quality of life, and/or do not present the chance for considerable recovery.
- Non-prescription food, litter, or other supplies.
- Flea control.

\_\_\_\_ I understand that Cat Town will cover reasonable medical expenses for my Adopted Cat at Cat Town’s Vet, or at a veterinary clinic outside of Oakland if preapproved by Cat Town.

\_\_\_\_ I understand that I must email [info@cattownoakland.org](mailto:info@cattownoakland.org) or call (510) 915-1454 so that Cat Town may authorize my veterinary appointments before I make them.

\_\_\_\_ I understand if I take my Adopted Cat to a vet without approval from Cat Town that Cat Town is under no obligation to reimburse me for that expense.

\_\_\_\_ I will administer medications, and follow the directions, provided to me by a licensed veterinarian resulting from appointments sponsored by Cat Town.

\_\_\_\_ I understand that Cat Town will not pay for medical expenses related to injury or neglect on my part, and that a Cat Town representative can remove Adopted Cat from my home in event of neglect.

\_\_\_\_ I will not hold Cat Town liable for any complications or unforeseen effects to my Adopted Cat resulting from surgical/medical procedures performed by Cat Town’s sponsored veterinarian visits.

\_\_\_\_\_ I understand that while Cat Town pays for veterinary supplies and costs, I will transport my Adopted Cat and pick-up all supplies on my own.
